



**PART I – LOTTO MAX JT Concert Ticket Giveaway**  
**Justin Timberlake: The 20/20 Experience World Tour Tickets at Rogers Arena**

**Qualified Entrant and Entry**

- 1) A Qualified Entrant is a BC resident 19 years of age or older. A Qualified Entrant does not include:
  - a) BCLC employees,
  - b) Justin Timberlake World Tour employees;
  - c) Facebook employees,
  - d) Shoutlet employees,
  - e) BCLC Lottery Retailers and their respective employees, and
  - f) Family and household members of same residing at the same address of all the above (a-e).
- 2) To obtain a Qualified Entry, a Qualified Entrant must:
  - a) “Like” the LOTTO MAX Facebook page,
  - b) Activate or click on the “LOTTO MAX” contest link;

- 11) Winners cannot assign a designate to attend or receive the prize; however, each winner is eligible to bring one (1) guest. Guests must be 19 years of age and are the responsibility of the Drawn Entrant under the same waiver conditions signed upon prize pick up.
