



## **1. RULES AND REGULATIONS**

SPORTS ACTION PROPS is governed by the Rules and Regulations Respecting Lotteries and Gaming of the British Columbia Lottery Corporation ("**BCLC**") which includes limitations of liability and are available from BCLC upon request.

## **2. DEFINED TERMS**

- a) "Action" means acceptance of a wager by BCLC.
- b) A "Prop" or "Proposition" or a "Sports Action Prop" is an individually numbered Sports Action Event listed on the Sports Action Menu that is available for betting on any of a variety of situations, circumstances or occurrences within a sports event or any other event chosen by BCLC.
- c) A "Prop Question" is a Prop listed on the Sports Action Menu in the form of a Yes or No question
- d) "Menu" means the SPORTS ACTION PROPS Menu entered on BCLC's computer gaming system containing those Sports Action Props available for selection.
- e) "Odds" means the balance of probability in favour of or against some Result that is assigned to each potential outcome of each individual Prop as determined by BCLC.
- f) "Result" means the final outcome of a Sports Action Prop listed on the Menu as defined by these Rules and as determined by BCLC at its sole discretion, including extra play, except in the following circumstances:
  - (i) in regular season hockey, the Result is the outcome at the end of play including overtime but excluding shootouts;
  - (ii) in playoff hockey, the Result is the outcome at the end of the game excluding shootouts and overtime;
  - (iii) for hockey "Third Period" Props, the Result does not include overtime and shootout play;
  - (iv) for football and basketball "Fourth Quarter" Props, the Result does not include overtime play;
  - (v) for baseball "Team to Score Last" Props, the Result includes extra innings played
  - (vi) in soccer, the Result is the outcome at the end of the soccer game, excluding shootouts or overtime; or



- (vii) the outcome at the end of an inning, period or portion of any Sports Action Event where BCLC determines the outcome by any method other than completion of the Sports Action Event.
- (f) “Pre-set Line” or “Line” refers to the projected Result of each Sports Action Prop assigned by BCLC. Players must predict whether the Result will be OVER or UNDER this Line.
- (g) “OVER/UNDER” means, where applicable, whether the Result of the Sports Action Prop will be greater than (Over) or less than (Under) BCLC’s Pre-set Line for that Sports Action Prop. A ½ point is added to BCLC’s Pre-set Lines to eliminate tie results.
- (h) “YES/NO” means, where applicable, whether the Result of the Sports Action Prop will be a Yes or a No answer to the Prop Question listed on the Sports Action Props Menu.
- (i) “Business Day” commences on or after 4:09 a.m. and ends at 4:08 a.m. on the following calendar date.
- (j) “Menu Date” is the date on which the Menu ends and is displayed after the Menu number.
- (k) “Total” means the combined statistics for both teams/all participants involved in the Event are added together to determine the outcome of the Prop.

### **3. ISSUANCE OF TICKETS**

- (a) To participate, a person must:
  - (i) present or submit a completed SPORTS ACTION PROPS selection slip predicting whether:
    - a) the result of a minimum of two (2) up to a maximum of six (6) Sports Action Props listed on the Menu will in each case be Over or Under BCLC’s Pre-set Line for each of those Props; or
    - b) the answer to a minimum of two (2) up to a maximum of six (6) Sports Action Prop Questions listed on the Menu will in each case be YES or NO for each of those selected Props Questions; or
    - c) any combination of a) or b), providing a minimum of two (2) up to a maximum of six (6) Props or Prop Questions listed on the Menu are selected;
  - and;
  - (ii) pay the authorized retailer, or BCLC where applicable, the required amount before the commencement of the Sports Action Event corresponding to the earliest Prop chosen from such Menu whereupon a ticket will be issued showing the Menu number, particulars of selections, potential payout, amount bet, control number or ticket ID number if applicable, and/or other relevant information.



#### **4. RESULTS**

- a) BCLC will determine the Results for each Prop and Prop Question offered based upon the criteria established by BCLC for each such Proposition and the official results or information from the official body of the game(s) to which the Prop bet is related.
- b) The outcome will be either:
  - (i) OVER or UNDER the Pre-set Line for each Prop listed on the Menu; or
  - (ii) a YES or NO answer to the Prop Questions listed on the Menu.
- c) Results are final when entered into the computer system by BCLC after the completion or cancellation of the Sport Action Event. In the case where the official body of the sport subsequently changes the results corresponding to the Prop after the Results have been entered by BCLC, the original Results (as determined by BCLC) will stand.
- d) BCLC shall assign Odds of 1.00 to both potential outcomes of the Over / Under Prop, or to the Yes / No Prop Question for those Sports Action Props that:
  - (i) have actually commenced or been completed prior to issuance of such ticket;
  - (ii) have a final result that is exactly the same as the Pre-set Line for that particular Prop;
  - (iii) are, for any reason, not completed in accordance with the rules and regulations governing that sport and as set out in the definition of Result above, or are not completed prior to 1:30 am Pacific Time following the event date and whichever occurs first;
  - (iv) do not meet the minimum requirements of play in order for Action, including:
    - a. for football player Props, the player must participate in one play of the game
    - b. for hockey and basketball player Props, the player must register at least 1 second of playing time
    - c. for baseball player Props, both the batter and/or the pitcher must complete a full plate appearance (resulting in the batter either reaching at least first base, or being recorded as an out);
    - d. for soccer player Props, the player must register at least one second of playing time;
    - e. for player Props in all other sports, the player must play at least one second of game time ;
    - f. for all Props, the game must be deemed completed by the rules and regulations governing that sport and the Results determined by BCLC for the Props to be considered complete;



- (v) have been or are deemed cancelled by BCLC.
  
- e) In baseball, a doubleheader means the same two (2) teams play each other twice on the same day. When a doubleheader occurs, the first ball game of the doubleheader will always be the Sports Action Event that the Sports Action Props will be based on, unless such game is the continuation of a suspended ball game, in which event the second game, the regularly scheduled game, will be the Sports Action Event corresponding to the Props listed on the Menu.
  
- f) If one or more, but not all, Props listed on a ticket are assigned Odds of 1.00 to both the Over and Under, or the Yes or No outcomes, the potential payout is determined based on the remaining Props selected.
  
- g) If all Sports Action Props listed on a ticket are cancelled or deleted, or are otherwise assigned an Odds value of 1.00, the ticket holder is eligible to a full refund.

## **5. WINNING SELECTIONS**

Winning Selections are determined by correctly predicting that the Result of all Sports Action Props selected from the Menu are either Over or Under BCLC's Pre-set Line, or are Yes or No answers to the selected Sports Action Prop Questions listed in the Menu.

## **6. WINNING TICKETS**

Any valid ticket bearing a Winning Selection is a Winning Ticket and entitles its holder(s) to claim the prize as calculated in accordance with Section 7 and shown on the SPORTS ACTION PROPS ticket.

## **7. PRIZES**

Subject to Section 9, the prize value for SPORTS ACTION PROPS is calculated by multiplying the Odds for all the Props selected to determine the total Odds for that ticket. The total Odds are then multiplied by the amount bet to determine the prize value. All predictions must be correct in order to win.

## **8. PRIZE CLAIMS**

Prizes must be accepted as awarded and must be claimed within one (1) year following the Menu Date listed on the ticket and in the manner stated on the back of the ticket, or, for PlayNow prizes, in the manner set forth in the Player Agreement.



**9. LIMITATIONS**

- a) The maximum total Odds payable on any SPORTS ACTION PROPS ticket, as calculated in accordance with Section 7, are 5,000 to 1.
- b) The aggregate amount of prizes that may be won on any day on SPORTS ACTION PROPS shall be limited to five million (\$5,000,000.00) dollars. If at the end of a particular day the aggregate amount of prizes that could be won, but for this provision, would exceed five million (\$5,000,000.00) dollars, then the aggregate amount of prizes payable on all winning tickets for that day shall automatically be reduced, and the amount payable as a prize in respect of each winning ticket for that day shall be equal to:
  - (i) the amount bet by such ticket, plus
  - (ii) the amount that would have been payable as a prize before any reduction less the amount of the wager multiplied by a fraction, having as its numerator five million (\$5,000,000.00) dollars, less the aggregate of all amounts bet on SPORTS ACTION PROPS for that day and, as its denominator, the aggregate amount of prizes that would have been payable on all winning tickets for that day before any reduction, less the aggregate of all amounts bet (the “**Adjustment**”):

- c) BCLC may, at its sole discretion, deem any Sports Action Event listed on any Menu to be cancelled, and shall deem any Sports Action Event, the essential particulars of which were shown in error on any ticket or which did not occur as stated on such Menu or commenced or was completed prior to the date and time shown on such Menu, to be cancelled.
- d) If there is a discrepancy between a published Menu and the Menu on BCLC’s computer gaming system, the latter shall prevail.



## **10. CANCELLATION OF A TICKET**

A person may only cancel a SPORTS ACTION PROPS ticket at the authorized retailer where such ticket was issued or, for a ticket issued on PlayNow, in the manner set forth in the Player Agreement, provided that such ticket is cancelled on the same Business Day the ticket was issued and prior to the start time of the earliest Sports Action Event chosen. Cancelled tickets are void.
