Re: Request for Records: BCLC File 19-100

British Columbia Lottery Corporation (BCLC) writes further to your December 5, 2019 request under B.C.'s Freedom of Information and Protection of Privacy Act (FIPPA) and BCLC's letter dated December 6, 2019.

You requested:

"All text messages between Robert Kroeker and Jim Lightbody, Jan. 1 2014 to July 1, 2019."

BCLC is providing six pages of records in response to your request. Some information has been withheld from disclosure under sections 14 and 22 of FIPPA. An additional 40 pages have been withheld in their entirety under sections 13, 14, 15 and 22 of FIPPA.

Below are the reasons for withholding information under each of the exceptions to disclosure noted.

Section 13 (policy advice or recommendations)

The information withheld under this section constitutes advice and recommendations by BCLC staff to BCLC decision makers.

Section 14 (legal advice)

The information withheld under this section consists of information that is subject to legal privilege.

Section 15 (harm to law enforcement)

The information withheld under this section is harmful to law enforcement because it would reveal anti-money laundering control processes. If disclosed, the information would be useful to those seeking to evade detection for committing money laundering offences.

Section 22 (harm to personal privacy)

The information withheld under this section consists of the personal information of BCLC employees that would be an unreasonable invasion of personal privacy if disclosed.




