

MARCH 18 and 21st 2015 LOTTO 6/49 SUPER DRAW CONDITIONS Approved March 3, 2015

1. SUPER DRAW

On Wednesday, March 18, 2015 and on Saturday, March 21, 2015, (each a "**Super Draw Date**"), Interprovincial Lottery Corporation ("**ILC**") will cause 55 additional Guaranteed Prize Draw Selections, from among all the Guaranteed Prize Draw Selections issued for the Super Draw Date, to be drawn at random. These will be known as "**Additional Guaranteed Prize Draws**". The first 6 Additional Guaranteed Prize Draw Selections to be drawn will each entitle the holder of such winning ticket to claim a prize of \$100,000; the next 49 Additional Guaranteed Prize Draw Selections to be drawn will each entitle the holder of such winning ticket to claim a prize of \$100,000; the next 49 Additional Guaranteed Prize Draw Selections to be drawn will each entitle the holder of such winning ticket to claim a prize of \$100,000; the next 49 Additional Guaranteed Prize Draw Selections to be drawn will each entitle the holder of such winning ticket to claim a prize of \$100,000; the next 49 Additional Guaranteed Prize Draw Selections to be drawn will each entitle the holder of such winning ticket to claim a prize of \$100,000; the next 49 Additional Guaranteed Prize Draw Selections to be drawn will each entitle the holder of such winning ticket to claim a prize of \$10,000.

2. WINNING SELECTIONS

A winning selection as a result of any Additional Guaranteed Prize Draw is determined where all the digits of such selection correspond in the same order to those of the Guaranteed Prize Draw Selection drawn ("Additional Guaranteed Prize Draw Winning Selection").

3. WINNING TICKETS

Any valid LOTTO 6/49 ticket for a Super Draw Date bearing one of the first six Additional Guaranteed Prize Draw Winning Selections drawn is a winning ticket and entitles its holder to claim a prize of \$100,000. Any valid LOTTO 6/49 ticket for a Super Draw Date bearing one of the 7th to 55th Additional Guaranteed Prize Draw Winning Selections drawn is a winning ticket and entitles its holder to claim a prize of \$10,000.

4. PRIZE CLAIMS

Prizes must be claimed within one year of the draw date.

5. ODDS OF WINNING

The odds of winning in any Additional Guaranteed Prize Draw are one out of the total number of Guaranteed Prize Draw Selections issued for that draw.

6. APPLICABLE GAME CONDITIONS

These Super Draw Conditions are supplemental to the ILC LOTTO 6/49 Game Conditions which are governed by the ILC Rules and Regulations Respecting Lotteries and Lottery Tickets and are available upon request. Unless otherwise defined herein, capitalized words have the meanings ascribed to them in the ILC LOTTO 6/49 Game Conditions.
