

HOST LOCAL GOVERNMENT PAYMENTS FOR FISCAL YEAR 2018/19

Each year, local governments that host casinos or community gaming centres receive a 10 per cent share of net gaming income generated by those facilities. The charts below show provincial payments made to Host Local Governments (HLG) in 2018/19 as compared to 2017/18. The calculations for HLG payments are done in accordance with the Host Financial Assistance Agreement between the Province of British Columbia and each HLG.

Net gaming income is defined as gaming revenue (revenue after prizes) from casino games less site specific costs including fees payable by BCLC to the service provider and an allocation of BCLC's administrative and operating costs as determined.. Service provider fees are attributed to the specific facility and vary by community. BCLC administrative and operating costs are attributed to each facility based on gaming revenue from the facility and therefore also vary by community.
