



## BC 50/50 GAME CONDITIONS AND PRIZE STRUCTURE STATEMENT

### 1. RULES AND REGULATIONS

BC 50/50 is governed by the Rules and Regulations Respecting Lotteries and Gaming of British Columbia Lottery Corporation (“**BCLC**”), which include limitations of liability and are available from BCLC at [bclc.com](http://bclc.com) or upon request.

### 2. ISSUANCE OF TICKETS

BC 50/50 tickets can be purchased in the following selection options: 1 selection for \$1; 2 selections for \$2; 3 selections for \$3; 4 selections for \$4; 6 selections for \$5; or 15 selections for \$10. The maximum wager per ticket is \$100.

To participate, an eligible person must request a ticket selection option and pay an authorized retailer, or generate and pay for a ticket from a self-serve terminal. Upon payment for the selection option, a ticket will be issued showing the Draw Day (as defined below) on which the ticket was purchased, the selection(s), the draw number(s), the amount wagered, the control number and other relevant information. Each selection is one (1) six-digit number issued in random order from amongst all available six-digit numbers from 000001 to 999999, inclusive, for that draw.

Consecutive draws can be played by requesting the appropriate number of consecutive draws to a maximum of ten draws and paying the appropriate amount.

### 3. DRAW DAY AND DRAW

Draws will occur at times as determined by BCLC, in its sole discretion, commencing on or after 4:06 a.m. to 4:05 a.m. Pacific Time on the following calendar date (the “**Draw Day**”). After the time sales for each such draw end, BCLC will cause one six-digit number to be drawn in a random manner from amongst all numbers from 000001 to 999999, inclusive, issued for that draw. Each draw is assigned a draw number. Ticket(s) qualify only for the draw with that same draw number. Should a draw not occur for any reason at the scheduled draw time, that draw will be conducted at the next available draw time.

### 4. WINNING SELECTIONS

The Winning Selection as a result of any draw is determined as follows:

### 5. WINNING TICKETS

Any valid ticket for any draw bearing the Winning Selection is a Winning Ticket and entitles its holder(s) to claim, for such Winning Selection, a prize calculated in accordance with Section 6 hereof. Only one prize is available to be won per draw. If a ticket becomes a Winning Ticket and is eligible for additional draw(s) following the draw date and draw number for which a prize is claimed, then such prize will be paid and an Exchange Ticket will be issued for the remaining draw time(s) and date(s) for which it is eligible and the ticket originally produced will, upon issuance of such Exchange Ticket, become void.

### 6. PRIZES

Prizes are determined as follows:

| Winning Selection    | Prize  |
|----------------------|--|
| Six (6) digit number | 50% of the value of all valid tickets sold for that draw number. BCLC may increase the prize from time to time at its sole discretion. |

### 7. PRIZE CLAIMS

Prizes must be accepted as awarded and must be claimed within one year from the date of the Draw Day on which the prize was won in the manner stated on the back of the ticket.

### 8. CANCELLATION OF TICKET

A person may only cancel a BC 50/50 ticket at the authorized retailer where such ticket was issued; provided that such ticket is cancelled on the same Draw Day the ticket was issued and prior to the time sales for the first draw appearing on the ticket end. Cancelled tickets are void.
