



**KENO, KENO BONUS, KENO PATTERN PLAY,
KENO DOUBLER AND KENO VALUE BUNDLES
GAME CONDITIONS and
PRIZE STRUCTURE STATEMENT**

1. RULES AND REGULATIONS

Keno, Keno Bonus, Keno Pattern Play, Keno Doubler and Keno Value Bundles are governed by the Rules and Regulations Respecting Lotteries and Gaming of British Columbia Lottery Corporation (“**BCLC**”) which include limitations of liability and are available from BCLC upon request.

2. ISSUANCE OF TICKETS

To participate, a person must:

- i. present a properly completed applicable Keno selection slip to, or request computer generated selections (“**Quick Pick**”) from, an authorized retailer; or
- ii. pick the selections or choose a Quick Pick on Playnow.com; or
- iii. generate a ticket from a BCLC self-serve terminal; and
- iv. pay the authorized retailer or BCLC, where applicable, the \$1, \$2, \$5 or \$10 wager for each completed Keno selection per draw.

From 1 to 10 numbers, inclusive, may be played for each selection whereupon a ticket will be issued showing the Draw Day (as defined below) on which the ticket was purchased, the selection(s), the amount(s) wagered for each selection, the draw number(s), the control number or ticket ID number and other relevant information, and where applicable, a Keno Doubler designation may randomly appear.

Keno Bonus is only available if a person participates in a Keno draw. Keno Bonus is not available on Keno Pattern Play. To play Keno Bonus, a person must pay the authorized retailer or BCLC, where applicable, an additional amount per draw equal to the cost of the Keno selection(s).

The maximum wager on Keno is \$100; the maximum wager on Keno Bonus is \$100. The total maximum wager per selection is \$200.

Keno Pattern Play wagers can be multiplied and the maximum wager is \$490 (maximum 49 draws X \$2 X 5 patterns). Consecutive draws can be played by marking the appropriate number in the applicable box on a selection slip or on PlayNow.com and paying the appropriate amount to the authorized retailer or BCLC, as applicable. Keno Pattern Play costs \$2 per play. Keno Pattern Play is not available on PlayNow.com.

Keno Doubler designation indicates the opportunity to randomly win double the prize amount on Keno, Keno Bonus and Keno Pattern Play tickets. Keno Doubler is available during temporary promotion periods, as determined by BCLC. Only valid

prize claims are eligible for Keno Doubler and the Keno Doubler designation in itself does not denote a win. Keno Doubler is free. Keno Doubler is not available on PlayNow.com.

Keno Value Bundles designation indicates the opportunity to purchase X number of advanced buy draws and receive Y number of free draws on Keno, Keno Bonus and Keno Pattern Play tickets, where X and Y are determined from time to time by BCLC. Keno Value Bundles is available during temporary promotion periods, as determined by BCLC. Value Bundles is not available on PlayNow.com.

3. DRAW DAY AND DRAW

Draws occur at intervals as determined by BCLC commencing on or after 4:50 a.m. to approximately 4:00 a.m. Pacific Time (the “**Draw Day**”). Should a draw not occur for any reason, that draw will be conducted at the next available draw time. Each draw is assigned a draw number. Ticket(s) qualify only for the draw(s) indicated on the ticket. After the sales cut-off time for each draw, BCLC will cause:

- a) One (1) Keno Bonus multiplier to be drawn from possible multipliers of 1.5X, 2X, 5X, 7X or 10X, and
- b) A Keno draw to occur: Twenty numbers to be drawn from 1 to 80, inclusive, for each such draw.

4. WINNING SELECTIONS

- a) Keno winning selections (“**Winning Selection**”) are determined as follows:

KENO Winning Selection	Consists of
Pick 1 (Only 1 number selected)	a match of 1 of the 20 numbers drawn
Pick 2 (Only 2 numbers selected)	a match of 2 of the 20 numbers drawn
Pick 3 (Only 3 numbers selected)	a match of 2 or 3 of the 20 numbers drawn
Pick 4 (Only 4 numbers selected)	a match of 2, 3, or 4 of the 20 numbers drawn
Pick 5 (Only 5 numbers selected)	a match of 3, 4, or 5 of the 20 numbers drawn
Pick 6 (Only 6 numbers selected)	a match of 3, 4, 5, or 6 of the 20 numbers drawn
Pick 7 (Only 7 numbers selected)	a match of 3, 4, 5, 6 or 7 of the 20 numbers drawn
Pick 8 (Only 8 numbers selected)	a match of 4, 5, 6, 7 or 8 of the 20 numbers drawn
Pick 9 (Only 9 numbers selected)	a match of 4, 5, 6, 7, 8 or 9 of the 20 numbers drawn
Pick 10 (Only 10 numbers selected)	a match of 0, 5, 6, 7, 8, 9 or 10 of the 20 numbers drawn

- b) Keno Bonus Winning Selections are determined by a winning Keno ticket and a player having elected to participate in the Keno Bonus on the winning Keno ticket.
- c) Keno Pattern Play Winning Selections are determined as follows:

Crazy Corners	No match or a match of 1, 2, 3, 4, 5, 6, 7, 13, 14, 15, 16, 17, 18, 19 or 20 numbers drawn
Bull's Eye	No match or a match of 1, 2, 3, 4, 5, 6, 7, 13, 14, 15, 16, 17, 18, 19 or 20 numbers drawn
Diamond Daze	No match or a match of 1, 2, 3, 4, 5, 6, 7, 13, 14, 15, 16, 17, 18, 19 or 20 numbers drawn
Any 4 Rows	No match or a match of 1, 2, 3, 4, 5, 6, 7, 13, 14, 15, 16, 17, 18, 19 or 20 numbers drawn
Any 5 Columns	No match or a match of 1, 2, 3, 4, 5, 6, 7, 13, 14, 15, 16, 17, 18, 19 or 20 numbers drawn
Any 3 Rows and 2 columns	No match or a match of 1, 2, 3, 4, 5, 6, 7, 13, 14, 15, 16, 17, 18, 19 or 20 numbers drawn
Quick Pick	No match or a match of 1, 2, 3, 4, 5, 6, 7, 13, 14, 15, 16, 17, 18, 19 or 20 numbers drawn

5. WINNING TICKETS

Any valid ticket for any draw bearing any Winning Selection of such draw is a winning ticket (“**Winning Ticket**”) and entitles its holder(s) to claim, for each such Winning Selection, a prize calculated in accordance with Section 6 hereof. Only one prize per Winning Selection may be claimed. If a Winning Ticket is eligible for additional draw(s) following the draw date for which a prize is claimed, then such prize will be paid and an exchange ticket will be issued for the remaining draw date(s) for which it is eligible and the ticket originally produced will, upon issuance of such exchange ticket, become void. If a Winning Ticket issued on PlayNow.com is eligible for additional draw(s), that ticket remains valid until the last remaining draw for which the ticket is eligible occurs.

6. PRIZES

a) Prizes for Keno are determined as follows for each \$1 played:

- b) Prizes for Keno Bonus are determined by multiplying the Prize value of the Keno Winning Ticket by the drawn Keno Bonus multiplier of 1.5X, 2X, 5X, 7X or 10X.
- c) Prizes for Keno Pattern Play are determined as follow:

# of matches in selected pattern	Prize
20 or 0 numbers	\$50,000
19 or 1 numbers	\$25,000
18 or 2 numbers	\$2,000
17 or 3 numbers	\$400
16 or 4 numbers	\$50
15 or 5 numbers	\$15
14 or 6 numbers	\$5
13 or 7 numbers	\$3

- d) If applicable, for those tickets which have a Keno Doubler designation the total prizing as set out in section a, b and c will be doubled.

7. PRIZE CLAIMS

Prizes for a particular draw must be accepted as awarded. Prizes must be claimed within one year from the date of the Draw Day on which the prize was won in the manner stated on the back of the ticket and for PlayNow.com prizes in the manner set forth in the Player Agreement. Prizes over \$2,000 including combined Keno, Keno Bonus and Keno Doubler prizes over \$2,000 will not be paid to the holder(s) of the Winning Ticket(s) until the next Draw Day.

8. PRIZE LIMITATIONS

The Prize amounts described in section 6 above are subject to the following limitations. These limitations apply with respect to any one Keno draw, and apply regardless of the amount wagered on such draw:

- a) The maximum prize payable on any one draw, not including Keno Bonus or Keno Doubler, is \$200,000. The maximum prize payable on any one draw for which a player elects to play Keno Bonus is 10X the value of the Keno prize, up to a maximum of \$2,000,000, or \$4,000,000 if Keno Doubler applies. These maximum amounts are subject to further reduction if BCLC's aggregate liability is reached, as described in section 8 b) below.
- b) BCLC's aggregate liability to all holders of tickets whose prize, but for this prize limitation clause, would exceed \$2,000 (each a "\$2,000 Plus Ticket") is \$2,000,000, less the aggregate of all prizes payable to holders of tickets with prizes of \$2,000 or less. For draws that include tickets with Keno Doubler,

BCLC's aggregate liability to \$2,000 Plus Ticket holders is \$4,000,000, less the aggregate of all prizes payable to holders of tickets with prizes of \$2,000 or less. Where the aggregate liability limits described above are reached, the prize payable to each \$2,000 Plus Ticket holder will be reduced on a pro-rata basis such that BCLC's aggregate liability to all \$2,000 Plus Ticket holders will be \$2,000,000 (or \$4,000,000 in the case of draws that includes tickets with Keno Doubler), less the aggregate of all prizes payable to holder of tickets with prizes of \$2,000 or less.

- c) In addition to the Keno restrictions stated in sections 8 a) and 8 b) above, Keno Pattern Play includes limitations restricting prize liability and payout whereby a maximum of 160 plays per pattern, regardless of how selected, will be available for each Keno draw.

9. CANCELLATION OF TICKET

A player may only cancel a ticket at the authorized retailer where such ticket was issued provided that such ticket is cancelled prior to the first draw listed on the ticket following the issuance of the ticket.

A ticket issued by a BCLC authorized retailer for consecutive Keno draws and where the first draw has already begun may be cancelled prior to the time sales for the second consecutive draw on such ticket ends. A re-issued ticket will be generated for the first draw. If sales for the second consecutive draw have ended or the second consecutive draw has begun or occurred, the ticket cannot be cancelled.

For draws during Keno Doubler promotion periods, the following restrictions apply. While retailers may cancel tickets printed in error, where a player is unable to make payment, or where BCLC otherwise authorizes; players cannot cancel validly issued tickets.

Any Keno ticket issued on PlayNow.com cannot be cancelled.

10. BCLC'S RIGHTS TO AMEND OR CANCEL

BCLC reserves the right at all times and in its sole discretion to amend or cancel the number of selection(s) available to be purchased on the same ticket or the number and types of lottery game(s) available to be purchased on the same ticket, or to change the method by which a ticket is issued to a person.

11. EFFECTIVE DATE

These Game Conditions are effective immediately and apply to Keno, Keno Bonus, Keno Pattern Play, Keno Doubler and Keno Value Bundles in all respects until they are further amended.
