Community Support

In 2024, Casino Nanaimo supported a wide range of local organizations and community initiatives through \$33,700 in charitable donations. Beneficiaries included the Nanaimo District Hospital Foundation, Dragon Boat Festival, Food 4 Schools, Island Crisis Society, COCO Café, Wounded Warriors, Women of Influence, and other community groups and events.

The casino also contributed \$6,689 in in-kind "dinner and play" packages to 19 local charity and community events, including the Cops for Cancer Tour de Rock, KidSport Golf Tournament, NRGH Foundation Golf Tournament, Paws for a Cause, and the Greater Nanaimo Chamber of Commerce.

Nanaimo Benefits

In 2024, the City of Nanaimo allocated its share of gambling revenue from hosting Casino Nanaimo to the City's Strategic Infrastructure Reserve (SIR) and to offset property taxes. The SIR supports a range of capital projects and initiatives through annual contributions from both gambling revenue and FortisBC.

In 2024, \$3.5 million from the SIR was used to fund several community-based projects, including:

- \$1.76 million toward the new Harewood Artificial Turf Fields, alongside support from the Investing in Canada Infrastructure Program.
- \$833,187 for transportation initiatives, including pedestrian safety measures and traffic calming.
- \$545,000 for property purchases.
- \$64,950 in grant funding to the Nanaimo Curling Club to support chiller repairs ahead of the curling season.

Did You Know?

The Strategic Infrastructure Reserve combines revenues from gambling and FortisBC to fund capital projects and reduce reliance on property taxes in Nanaimo.

SPOTLIGHT

Local Impact

As part of its regular operations, Casino Nanaimo invested over \$225,000 into the local economy by working with more than a dozen local vendors, including Tubber Plumbing and Draining Services, DenMar Electric, Fitzgeralds Property Maintenance, and Advanced Automatic Doors Ltd.
