British Columbia's Casino, Community Gaming and Bingo Facility Gambling Operations Model

BCLC enters into Operational Services Agreements (OSAs) with private-sector service providers to carry out the day-to-day operations at gambling facilities including casinos and community gaming centres. Under this model, service providers are responsible for financing and construction of new gambling facilities, as well as the ongoing maintenance and repairs. The current OSA structure defines the service and operating responsibilities of service providers, as well as the following commissions:

Casino Games

- 25 per cent of net win¹ from slots and electronic table games
- 77.5 per cent of net win from poker and of net win from craps
- 62.5 per cent of net win from low-limit blackjack
- 40 per cent of net win from high-limit tables (except for high-limit craps, 75 per cent of net win)
- 42.5 per cent of net win from all other table games

Bingo Games

- 90 per cent of bingo sales (after prizes are paid) on the first \$10,000 per week
- 45 per cent of bingo sales (after prizes are paid) greater than \$10,000 per week
- 60 per cent of weekly net win from bingo games (paper bingo only)
- 25 per cent of weekly net win from electronic pull tabs

Loyalty Program Commission²

BCLC's Loyalty Program Commission program provides service providers a percentage of net win on BCLC's online gambling website, PlayNow.com, for eligible players.³

- Proportional share 4 of 15 per cent of eSlots net win
- Proportional share of 15 per cent of eTables net win
- Proportional share of 15 per cent of Live Casino net win
- Proportional share of \$10 conversion fee

The terms of the OSA require service providers to submit annual business plans that include commitments to capital and operating investments in properties over the term of the contract. In addition, through a Facility Investment Commission (FIC) program, service providers earn commissions based on the execution of an investment plan agreed upon at the time of signing the current OSA.

OSAs provide a framework for BCLC to hold service providers accountable for investment commitments and service standards that drive growth and new amenities, while supporting the health of our players. They also include accountability measures that support BCLC's oversight in the areas of compliance and security, including escalation mechanisms and progressive discipline measures.

⁴ "Proportional Share" with respect to an eligible player means a calculation expressed as a percentage of the eligible player's wagers at the service provider's land-based facility in the specified period as the numerator, and the eligible player's total wagers at all BCLC managed land-based gaming facilities for the specified period as the denominator.



¹ Net win is defined as player wagers less winnings and is adjusted for free play and progressive jackpot contributions.

² The commission rates listed in this section refer to the terms of the OSA from Aug 30, 2021 – December 31, 2023. On January 1, 2024, the loyalty program commissions rates were adjusted to 18% of eligible player eSlots net win, 18% of eligible player eTables net win, and 17% of eligible player live casino net win in the commission period. Between January 1, 2024, and March 31, 2024, no loyalty program commissions were paid to service providers, and, therefore, no amounts for this period have been included in the values on page 4 and 5 of this report.

An eligible player is defined as an active casino Encore Rewards member who did not have a PlayNow.com account and then opened one and placed a wager during a specific timeframe, or a new or active casino Encore Rewards member who did not have a PlayNow.com account or had an inactive account and opens or reopens an account and places a wager following the terms and conditions of a PlayNow.com marketing offer received.
