Good morning everyone

Yesterday and the day before the executive team met to review the budget submissions for FY18 and the five year forecast we must provide to government. Overall requests for travel increased for FY18 by \$600,000 or ~ 21%. The rationales supporting the increases were reviewed. Despite the reasons provided for this increase, there are clear signals from government that Crowns will be expected to have tight controls on travel expenses. It would simply not meet the direction that has been signaled from government and the direction we expect to receive to propose a travel cost increase of this magnitude. Accordingly, the executive team took the decision to have FY18 travel budgets held flat to FY17 budgets by division. Travel budgets between cost centers within the division can be reallocated as necessary but the travel costs by division will need to be flat to FY17 budget. Adjustments required to reflect this direction must be made by October 4th (at the cost center level). Please work with Mike Hays to have necessary changes in your budgets in place by this date.

All Directors must work together to ensure overall divisional travel budgets submitted are flat to FY17 (or if increasing, must show the corresponding decrease in another cost center). If you have any questions, please contact myself or Mike Hayes. The management team across the company will need to work to find efficiencies (e.g. increasing car vs. air travel between offices) to hold FY18 travel flat. There are plans to provide an additional fleet vehicle and we encourage virtual meetings as much as possible with the tools and technology available. In FY18 I will be challenging us as a team to manage travel closely so that we meet the objective of being flat on travel while still meeting our business needs. We will discuss strategies to help us achieve this objective at our next managers meeting.

3.4 All other reportable electronic funds transfers (non-SWIFT)

The rest of this guideline provides information about the reporting requirement for international "non–SWIFT" EFTs. This applies to you if you are a financial entity, a money services business or a casino. An EFT is the transmission of instructions for a transfer of funds through any electronic, magnetic or optical device, telephone instrument or computer. In this context, SWIFT EFT messages are excluded, as explained in subsection 3.3.

You have to send a non-SWIFT EFT report to FINTRAC for the following transactions.

Outgoing EFTs

These are instructions sent electronically for the transfer of \$10,000 or more outside Canada at the request of a client in the following manner:

in a single transaction; or

in two or more transfers of less than \$10,000 each (that total \$10,000 or more) in the following 24-hour rule situations:

if you are an entity, your employee or senior officer knows the transfers were made within 24 consecutive hours of each other by or on behalf of the same individual or entity; or

if you are an individual, you know the transfers were made within 24 consecutive hours of each other by or on behalf of the same individual or entity.

This type of EFT requires that you send an Outgoing International Non-SWIFT EFT Report (EFTO) to FINTRAC.

It can happen that a client requests a transfer of funds and, instead of sending the EFT yourself, you order someone else that is a financial entity, a money services business or a casino in Canada to send it. In this case, you have to make the related EFT report (EFTO) to FINTRAC unless you provide them with the client's name and address. In other words, if you give them your client's name and address, you do not have to report the EFT. See Appendix 3 for example scenarios of this type of situation.

If you send an EFT on your own behalf (not on behalf of a client) to an individual or entity in Canada, you do not have to report it, even if the final recipient of the funds is outside Canada

Incoming EFTs

These are instructions sent electronically for the transfer of \$10,000 or more from outside Canada at the request of a client in the following manner:

in a single transaction; or

in two or more transfers of less than \$10,000 each (that total \$10,000 or more) in the following 24-hour rule situations:

if you are an entity, your employee or senior officer knows the transfers were made within 24 consecutive hours of each other by or on behalf of the same individual or entity; or

if you are an individual, you know the transfers were made within 24 consecutive hours of each other by or on behalf of the same individual or entity.

This type of EFT requires that you send an Incoming International Non-SWIFT EFT Report (EFTI) to FINTRAC.

If you are a financial entity, a money services business or a casino and you received instructions for a transfer of funds from outside Canada, you have to make the related EFT report (EFTI) to FINTRAC, even if you have to forward the same instructions to another financial entity, money service business or casino in Canada. However, if you receive instructions for a transfer of funds from outside Canada from another financial entity, money services business or casino in Canada, you do not have to make an incoming EFT report, as long as the EFT contained the name and address of the beneficiary. If the EFT did not contain the name and address of the beneficiary and the original sender was outside Canada, you also have to make an incoming EFT report. This is true even if you do not get a copy of the instructions received by the other financial entity, money services business or casino.

2.2 When does a casino disbursement report have to be made?

In the context of casino disbursement reports, only disbursements that you pay out in the following types of transactions must be reported:

- redemptions of slot tickets, chips, tokens or plaques;
- front cash withdrawals;
- safekeeping withdrawals;
- advances on any form of credit, including advances by markers or counter cheques;
- payments on bets, including slot jackpots;
- payments to clients of funds received for credit to that client or any other client;
- cashing of cheques or other negotiable instruments; and
- reimbursements to clients of travel and entertainment expenses.

This includes amounts paid out in cash, by cheque, by transfer or many other methods, but it only includes amounts paid out to a casino client or patron and only if they were paid out for the types of transactions listed above. However, in this context, disbursements exclude any amounts that you pay out in casino chips, tokens or slot tickets.

A disbursement does not include the following:

- a payment for services or goods to the casino's staff, suppliers or entertainers
- an amount deposited to the casino's bank account
- an amount deposited to a front money account
- an amount applied to a casino credit account
- an advance on a client's credit card, unless the credit card was issued by the casino
- a "comp" (complimentary) payment or redemption of player points
- a cash bonus payment (rewards program)
- cash received by the casino (see *Guideline 7: Submitting Large Cash Transaction Reports to FINTRAC* for information about when receipts of cash are reportable)

Having said that keep in mind that GPEB does have a broad, essentially limitless, authority to demand and receive info from us where they are conducting a bona fide investigation or audit. I know you will keep this in mind. While I want us to make sure we have proper protocols and controls I also want us to facilitate the flow of info as far as possible - especially providing them with generic data like monthly LCT and STR trends. So even where we feel GPEB is being unreasonable we need to be as flexible and accommodating as we can. (Note: this is only related to Casino STR

and related activity at this point.)

, although could not point to a single example of where they had not received info on request. He also stated that they will likely ask for all unsubstantiated UFT's as that was also "evidence of potential money laundering" and if we continued to be difficult they would likely circumvent the request by getting the data straight from the SP's. I have briefed Kevin and he has concerns that could constitute a breach of privacy laws.

We discussed that there were a number of action items from the last meeting including a GPEB PIA which would be shared jointly with BCLC and GPEB would also provide details of their data management practices, neither of which has happened. He seemed unaware of either. I will touch base with Anna to discuss further.

My proposed response:

Hi Len,

Thank you for your email.

Yes, Bob called me yesterday to discuss a couple of recent section 86(1) requests. Essentially BCLC had asked for further detail in the actual Sect86(1) so that we could fully accommodate the request and that appeared to be the basis for the call.

During the conversation Bob also outlined concern for providing rationale for the investigation in a Sect 86(1). However you have since addressed that in your email. He was also concerned that I was being intentionally uncooperative by requiring a GPEB staff member to attend the BCLC Vancouver office to collect copies of STR reports and sign for them.

It should be noted that Anna and I had discussed on two separate occasions that any request for STR's would likely take place once a month.

As I am sure you are aware the OIPC has made a number of comments recently regarding the disclosure of personal information particularly as it pertains to Government entities. The recent review BCLC conducted on information sharing has highlighted that BCLC currently use multiple methods to provide information to GPEB. For example in the Investigations and Compliance world

Y/GPEB Audit has open access to BCLC systems, albeit in a controlled environment with no printing capability

Y/eGaming Investigation files are mostly transferred via SFTP servers

Y/Lottery Investigations transfer data via email from Salesforce.

Y/Most Casino Investigation information is obtained by GPEB directly from SP Surveillance in hard copy form and is signed for at the site. Most of these practices have been in place for a number of years.

Y/Some data is transferred via unsecure email

As a result of that review BCLC made only one change to process. It was identified that because of the sensitivity of the information and the amount of personal information contained in a STR that this was the highest risk area for a Privacy Breach. The decision was made to stop sending copies of STR reports to GPEB without a formal request for information. STR information like any information is always readily available on request. Providing hard copies was consistent with current casino practices, expectations of our privacy group and GCA Sect 79 requirements. It should also be noted I had mentioned this proposed change with Derek, Anna and Bob for months previously before the actual change was implemented.

At a GPEB/BCLC compliance meeting conducted on October 7th, 2016 info sharing processes were discussed in detail. Anna agreed to provide details of a GPEB Privacy Impact Assessment (PIA) with BCLC which would cover GPEB's data management and data protection practices. believe that PIA is underway. As s 22

As a sign of cooperation in that meeting BCLC advised there would be no changes to existing information flows for eGaming, Lottery Investigations or for Compliance Audits until we had all had the chance to independently review our practices further and discuss the PIA. We also hoped there would soon be further clarity on Roles and Responsibilities which would help define some of the processes. Anna, Kevin and I will reconvene next month to discuss our findings and hopefully come to an agreement which will include addressing the method of sharing information.

I certainly don't purport to be an expert on privacy and I don't have any specific concerns related to FOIPPA as in my mind this appears to relate directly information sharing practices allowed under the GCA. Of course FinTRAC and RCMP are not bound by Section 79 of the GCA therefore any information sharing we have with them is governed differently.

Casino data theft sparks talk of class-action suit

Class-action lawyers wasted little time Friday in jumping in on word of a cyberattack on an Ontario casino in which sensitive information was stolen.

They announced plans for a lawsuit that would seek \$50 million in damages from Casino Rama, north of Toronto, and began asking possible victims to sign on.

"The class action will be commenced on behalf of employees, customers and vendors of the Casino Rama Resort whose confidential information was compromised by the privacy breach," the lawyers said.

"The proposed representative plaintiffs in the lawsuit are customers who gave the resort their confidential information, including financial information." The statement of claim would be filed in Superior Court on Monday given the Remembrance Day holiday on Friday, said lawyer Ted Charney, one of those involved.

On Thursday, Casino Rama Resort in Rama, Ont., warned its customers, vendors as well as current and former staff to keep an eye on their bank accounts, credit cards and other financial information. The casino said it had "recently" discovered it was the victim of a cyberattack that resulted in the large-scale data theft.

Stolen data appeared to include internal financial and security-incident reports, emails, payroll and client information, social insurance numbers, and dates of birth.

"The hacker claims that the employee information dates from 2004 to 2016, and that some of the other categories of information taken date back to 2007," the **casino** said in a statement on its website. "We can confirm that certain employee and customer information was stolen."

The statement also warned the hacker could publish the stolen data.

"This is a massive privacy breach," Charney said in announcing the proposed lawsuit.

"We still do not know the whole story but it looks like Casino Rama rolled the dice with employee, customer and vendor data, rather than invest in state-of-the-art security measures."

No allegations have been tested in court and it was still much too early for any statement of defence.

"We continue to work with the proper authorities on the ongoing investigation and are limited in how much detail we can provide," **casino** spokeswoman Jenna Hunter said in an email Friday. "We deeply regret the this situation and recognize the seriousness of the issue."
