British Columbia Lottery Corporation (BCLC) writes further to your March 28, 2019 request under B.C.'s *Freedom of Information and Protection of Privacy Act* (FIPPA) and BCLC's letter dated March 28, 2019.

You requested:

"...a list of purchase locations and times of winning tickets for draw number 597522 Pacific Hold'Em....I would like to request proof of the other winning tickets and the poker hands they had."

BCLC has interpreted "purchase locations" to mean the cities where the tickets were purchased.

In accordance with section 6(2) of FIPPA, BCLC has created a record, enclosed in the body of this letter, in response to your request. The record represents the purchase locations, purchase times, winning poker hands, winning hand cards, bet amounts and prize amounts for all of the winning tickets for draw number 597522 for the Pacific Hold'Em Poker draw that was held on March 13, 2019 at approximately 6:37 pm.
