Re: Request for Records: BCLC File 19-043

British Columbia Lottery Corporation (BCLC) writes further to your May 6, 2019 request under B.C.'s *Freedom of Information and Protection of Privacy Act* (FIPPA), BCLC's letter dated May 7, 2019 and various email correspondence between you and BCLC from May 8, 2019 to May 30, 2019.

Your original request was for:

"...electronic copies (sent via email) of BCLC's internet lottery results (since launch) and its internet casino results (since launch)."

You clarified this request via email on May 30, 2019 to be for:

"The percentage of eGaming revenue that was attributable to eLottery and the percentage of eGaming revenue that was attributable to eCasino for the years 2010 through 2018 inclusive, broken down by year."

In accordance with section 6(2) of FIPPA, BCLC has created a one-page record in response to your request. The record represents the percentage of eGaming revenue that was attributable to eLottery and the percentage of eGaming revenue that was attributable to eCasino for the fiscal years 2010 through 2018 inclusive, broken down by year. However, BCLC is withholding this record in its entirety under section 17 of FIPPA.

Below are the reasons for withholding information under each of the exceptions to disclosure noted.

Section 17 (harm to the financial or economic interests of BCLC)

The information withheld under this section is harmful to BCLC's financial or economic interests because disclosure would reveal financial, commercial or technical information that belongs to the public body that has, or is reasonably likely to have, monetary value.
