Re: Request for Records: BCLC File 22-042

British Columbia Lottery Corporation (BCLC) writes further to your October 7, 2022 request under B.C.'s *Freedom of Information and Protection of Privacy Act* (FIPPA).

You requested:

"...the number of \$3 play purchased or free-plays together for historical 649 games in 2022. In other words, I want to know how many tickets are purchased. It is useful to find out how many plays are in one game because it will help me what were the odds (the one-million guaranteed or/gold ball white ball prize)..."

As indicated in its acknowledgement letter, BCLC is interpreting your request to be for:

The number of \$3 plays for each Lotto 6/49 draw (both including and excluding free plays) across Canada for all draws between January 1, 2022 and October 7, 2022.

In accordance with section 6(2) of FIPPA, BCLC has created a record, enclosed, in response to your request. The record represents information pertaining to the Lotto 6/49 game. The information is categorized into the following columns: draw date, national number of plays sold (including free plays), national number of plays sold (excluding free plays), between January 1, 2022 to October 7, 2022.

In your original request wording, you indicated that you intend to use this record to better understand the odds of winning the guaranteed \$1 million prize and the Gold Ball prize. If you are seeking information on the odds of winning the Lotto 6/49 game, please refer to BCLC's website for more information at:

BCLC notes that it only collects the information described above for the province of B.C. Hence, some information in the records originated from other provincial lottery corporations and was not independently audited by BCLC for the purpose of this request.
