British Columbia Lottery Corporation (BCLC) writes further to your December 19, 2022 request under B.C.'s *Freedom of Information and Protection of Privacy Act* (FIPPA) and correspondence between you and BCLC from December 19, 2022 to January 9, 2023.

Your original request was for:

"...how many combo plays ticket with extra Vin in the last 5 years. What is the biggest amount combo plays tickets with extra Win in the last 5 years.. How many combo plays tickets without extra win in the last 5 years what is the biggest price on those tickets. How many combo play tickets with extra win \$1 in the last 5 years. information for 649 lotto Max and bc49."

You clarified this request via email on January 5, 2023 to be for:

"For BC/49, Lotto Max and Lotto 6/49:

- 1. How many combo play tickets, with the Extra, prizes of \$100.00 or more were redeemed in BC from December 19, 2017 to December 19, 2022?
- 2. What was the biggest prize amount that was redeemed in BC from a combo play ticket, with the Extra, from December 19, 2017 to December 19, 2022?
- 3. How many combo play tickets, without the Extra, prizes of \$100.00 or more were redeemed in BC from December 19, 2017 to December 19, 2022?
- 4. What was the biggest prize amount that was redeemed in BC from a combo play ticket, without the Extra, from December 19, 2017 to December 19, 2022?
- 5. How many combo play tickets, with the Extra, prizes of \$1.00 were redeemed in BC from December 19, 2017 to December 19, 2022?"

In accordance with section 6(2) of FIPPA, BCLC has created a record, enclosed in the body of this letter, in response to your request.
