Each year, local governments in B.C. that host a gambling facility receive a 10 per cent share of the net gaming income those facilities generate. Last year, 32 Host Local Governments across B.C. received **\$66.9 million** in provincial gambling revenue to fund local projects and initiatives

The City of Vancouver allocated its share of provincial gambling revenue from hosting Parq Vancouver, Hastings Racecourse and Planet Bingo to a range of community initiatives, including \$18,360 to Frog Hollow Neighbourhood House, whose mandate is to support intergenerational approaches to build a strong sense of community identity and reduce barriers to inclusion. The City of Fort St. John continued to use its share of gambling revenue from hosting Chances Fort St. John to help operate the Pomeroy Sport Centre, an ice and sports recreation and events centre that features one of only five Olympic-size long track speed skating ovals in North America, along with two NHL-size ice rinks.

B.C. First Nations revenue-sharing agreement

In fiscal year 2021/22, the Province of B.C. distributed \$91.2 million to First Nations in B.C. as part of the BC First Nations Revenue Sharing Agreement, which provides seven per cent of BCLC net income to First Nations. Funds are used to support health and wellness; infrastructure, safety, transportation and housing; economic and business development; education, language, culture and training; community development and environmental protection; and capacity-building, fiscal management, and governance.

Net gaming income is defined as net win (revenue after prizes) from casino games less fees payable by BCLC to the casino operator in accordance with International Financial Reporting Standards. Operator fees are attributed to the specific facility and vary by community. BCLC administrative and operating costs are attributed to each facility based on net win from the facility and therefore also vary by community.

Host Local Government Payments

FOR FISCAL YEAR 2021/22

Local governments that host a gambling facility in their community receive a 10 per cent share of the net gaming income it generates each year. As a public-health measure to slow the spread of COVID-19, all casinos, community gaming centres and bingo halls across B.C were temporarily closed from March 16 2020 to July 1, 2021. As a result of these closures, Host Local Governments did not receive Host Local Government Payments during this time. Payments resumed following the successful reopening of gambling facilities on July 1, 2021.

PLAYER HEALTH INITIATIVES

Reducing Barriers to Support Programs

The GameSense Advisor (GSA) Program first piloted its virtual services in 2020 as a way to offer player health support while casinos were closed due to the pandemic. Since then, the program continues to offer support to more players across the province.

This year, BCLC expanded the program by adding a new virtual enrollment option for the Voluntary Self-Exclusion Program, made possible with the support of our GSAs. Individuals can now self-exclude from gambling facilities by making an appointment to speak with a GSA via telephone or live chat. The opportunity to enroll virtually serves as an important step to reducing barriers for individuals who need to take a break from gambling but require more privacy, discretion and support.

While enrollment inside gambling facilities and BCLC offices are still options, we will continue to focus on using this inclusive approach for individuals requesting off-site enrollments and additional support.




